3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Glan Dwr poultry unit was visited on 28th April 2026.

Condition 1.1 - General Management

1.1.1 (a) - the incident response plan is outdated, for example, section 15 has the previous managing director listed as the contact in an emergency

1.1.1 (a) - the environment policy is missing a review date

Action: Update the incident response plan with current information, and update the environment policy to include a review date (should be reviewed no less than every 4 years) by **June 11th 2026**

Condition 3.2 - Emissions of substances not controlled by emission limits

3.2.1 - Sheds 4, 5, 6, 9, 11, and 12 had damaged roof fan covers, which could allow rainwater to enter the shed, compromising the quality of the litter and producing excess waste.

Action: Repair the damaged roof fan covers on sheds 4, 5, 6, 9, 11, and 12 by **August 11th 2026**.

3.2.1 - The above ground wastewater/slurry tank has two valves right next to each other. The Water Resources (Control of Agricultural Pollution) (Wales) Regulations 2021 require two valves on such a pipe at least 1m apart. Paragraph 10 of Schedule 6 reads:

10.—(1) Subject to sub-paragraph (3), if the slurry storage tank or any effluent tank or reception pit is fitted with a drainage pipe there must be two valves in series on the pipe with each valve separated from the other by a minimum distance of 1 metre.

(2) Each valve must be capable of shutting off the flow of slurry through the pipe and must be kept shut and locked in that position when not in use.

(3) Sub-paragraph (1) does not apply in relation to a slurry storage tank that drains through the pipe into another slurry storage tank if the other tank is of equal or greater capacity or if the tops of the tanks are at the same level.

Action: Increase the distance between the two valves to at least 1m by **August 11th 2026**

3.2.1 - A gutter downpipe on shed 12 was missing

Action: Replace this missing downpipe by **August 11th 2026**

3.2.1 - The drainage diverters have been upgraded to newer ones, but they no longer sit flush with the sump floor, allowing sediment to sit rather than enter the wastewater tank.

Action: Raise the floor of the sump so it is flush with the diverter channels, allowing all site washings to be captured effectively by **August 11th 2026**

Recommendations:

These comments are not part of the permit requirements but were noticed during the inspection:

- 1) Farm Checklist Audit Report was present and signed off, but missing some confirmations across various categories
- It is recommended you prompt the third parties and site staff involved in the site turnaround to complete the paperwork as required to demonstrate complete biosecurity control
- 2) Risk assessments are present and signed off on the master sign-off but not for individual RAs
- It is recommended both documents are correctly signed off, or the format updated to meet the required information, i.e. only one sign-off point if only one is needed

Summary

Overall the site was well maintained, with improvements made to the maintenance and health & safety records kept since the last visit. The site continues to perform well during the inspections with good control over the paperwork and almost all site infrastructure.
