The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

Please note: this CAR is dated 25/11/2025 as the non-compliance relate to the 2025 monitoring programme, however for clarity I carried out the compliance assessment on 11/5/2026.

Issue identified:

The Urban Waste Water crude data for 11/03/2025 was not provided within 1 month as per the required norm. It was received on 25/11/2025.
