CARS form generated following site visit to PARC sewage treatment works on the 08/05/2026.

The environmental officer from Natural Resources Wales met the operational supervisor from Dwr Cymru cyf at 8:45 am.

The site was descriptive in size, we inspected the inlet, the aeration, the settlement tank, the sludge tank and the outfall to the Afon Llafar.
