CARS form generated following site visit to Llanfor sewage treatment works to inspect emergency outfall on the 07/05/2026.

The environmental officer from Natural Resources Wales met the operational supervisor from Dwr Cymru cyf at 9:25 am.

The site is descriptive in size, we inspected the inlet, the aeration (Oxydigest), the settlement tank, and the emergency outfall.

No signs of none compliance identified. Thank you for the site visit.
