Demonstrating Compliance with Permit Condition 1.1.1 - Cat 3: Permit Condition 1.1.1 & 1.1.2

You have been given this Category 3 breach of permit conditions 1.1.1 and 1.1.2 as you have failed to submit a report that investigates the Approach To Limit result for emissions of VOCs reported in the stack emission monitoring for your site for 2025.

Compliance actions are not optional, permit conditions are written to be environmentally protective and therefore it is reasonably foreseeable that the failure to comply with a permit condition will result in environmental harm.

Action: Submit a report **by 12 July 2026** that considers:

1. the engine maintenance schedules and engine oil analysis with the aim of identifying potential problems with the operation of the engine that may affect the emissions
2. potential impacts due to inlet gas composition
3. the condition of internal engine parts such as cylinder heads and seals
4. the engine management system and engine set-up

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.

Important information

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
