4. Details of our assessment

Summary of Flow Pass Forward (FPF) (NRW FPF 2025 Submission) data as required by permit conditions linked to UMON3,4 driver submitted on 28th February 2025.

The result for FPF > 92% was 88.01%

As the FPF percentage above 92% of FFT was less than 95%, this is a breach of permit condition 3.1.5

This is a category 3 breach pending a review of guidance

Cause of breach and route to compliance provided by DCWW:

Ultrasonic was damaged. Ops have repaired. Awaiting uMON3 radar installation. Monitoring - trending towards compliance.
