## 4. Details of our assessment

4.2.2 Late Data (S4.1 UWWTR Inlet Sample Point, Monthly Report to be submitted within 28 days) - UWW Crude data for 04/03/2025 and 20/03/2025 was not provided within 1 month. Received 25/11/2025.

February's crude data was submitted instead of March's data. This was raised by NRW on 25/11/2025. This was investigated and the root cause was the macro that is used for the monthly reporting. An error occurred when producing the final file for submission. March's data was submitted on 25/11/2025.

*The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Urban Waste Water conditions.*

*Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 12/05/2026.*
