### 4. Details of our assessment

This was a pre-arranged site inspection to check compliance with one of the requirements detailed in Schedule 1 of the Regulation 36 notice that was issued on 11th February 2026.

Schedule 1 of the notice states the following;

- *During Quarter 1 2026 (January to March) operator to organise a suitable date which will be agreed with NRW for NRW to come and observe the operator monitoring all leachate levels across the whole landfill site and observe the operator conducting CCTV surveys of all leachate infrastructure. This should include but not be limited to a dip to base for all leachate wells.*

Suitable dates were agreed with NRW to attend site on Monday 27th April and Tuesday 28th April 2026 to observe this monitoring.

The site used their own operational staff alongside contractors from SGG Environmental Solutions Ltd.

NRW officers observed this work over the two days. Only the following monitoring leachate wells (see Table S3.1 in the permit) could be accessed during the two days:

LCP1

LCP2

LCP3

LCP6

LCP8

RMLP9A

LCP7 had collapsed and it was not known how long this monitoring point had been damaged. RMLP9B and RMLP9C could not be fully accessed as staff stated the wells were too high for them to access safely.

RMLP9D could not be accessed but staff suspected this well had collapsed.

Permit condition 3.7.5 states the following;

*Permanent means of access shall be provided to enable sampling/monitoring to be carried*

*out in relation to the emission points specified in schedule 3 tables S3.1, S3.2, S3.3, S3.4, S3.5, S3.6, S3.7, S3.8, S3.9, S3.10 and S3.11 unless otherwise agreed in writing by Natural Resources Wales.*

### Action

The operator must ensure that all leachate monitoring wells are functioning and can be accessed to enable monitoring to be carried out

This part of the Regulation 36 notice has been complied with.

During the attendance on site to observe the survey work, no other activities were taking place in relation to the permanent capping except for deliveries of geosynthetic membrane. Site confirmed that repairs had been made to the plastic cap following submission of a CV for a different CQA engineer to supervise repairs. Site stated the damage had occurred during a period of high winds.

NRW officers observed an amount of liquid underneath the plastic cap at the toe of Phase 9D&E (see photo below). Leachate was seeping underneath the plastic membrane and into the surrounding gravel and soils which lead underneath the haul road.

This is in the area where pools of leachate were previously observed and which information has been submitted that stated this issue was remediated (See CAR\_NRW0051527).
