The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Cyf.'s compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as this non-compliance relate to annual 2025 data, however, for clarity the compliance assessment was undertaken today 11th May 2026.

Issue Identified:

3.3.1 (c) Efficacy Monitoring Shortfall. Eight sampling shortfalls due to deviating data.
