## 4. Details of our assessment

Dear Permit Holder

The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Cyf.'s compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however, for clarity the compliance assessment was undertaken on 13th May 2026.

### Issues identified

1) OSM 1 Sampling shortfall: 2 results for BOD and Total Suspended Solids missing for the calendar year. Reported on ASR as due to fluvial flooding.

#### Action:

Provide feedback to NRW on how Dwr Cymru Cyf. plan on avoiding future issues of obtaining samples due to fluvial flooding issues.

#### Timescale:

Action due by 1st July 2026.

2) OSM 1 Efficacy Monitoring Shortfall. Eight sampling shortfalls due to deviating data.

#### Action:

Provide feedback to NRW on how Dwr Cymru Cyf. plan on avoiding future issues of having efficacy monitoring shortfall in the future.

#### Timescale

Action due by 1st July 2026.
