## 4. Details of our assessment

*The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions*

*Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 13/05/2026.*

### Actions

**1)** Condition 3.3.8 states "Unless otherwise agreed in writing by Natural Resources Wales, after becoming aware, or following notification that a sample has not been taken on the schedule 3C Monitoring Programme pre-scheduled date, or is lost, or a result for that sample cannot be reported, the operator shall notify Natural Resources Wales of the missed event and the reschedule date as soon as reasonably practicable." DCWW are required by permit to comply with this condition surrounding re scheduling of samples. - **Due 1st July 2026.**

### **Late Reschedule Notification – Sample ID 8570724 (04/07/2025)**

This notification is submitted outside the required 21-day reporting period. The delay relates to a late reschedule arising from a courier temperature failure, coupled with a failure to follow internal procedures to cancel the analysis of affected samples.

The issue was initially identified by DCWW in early September 2025. It was subsequently raised with NRW on 23 October 2025, with full details provided on 28 October 2025. This exceeds the 21-day notification requirement.

**2)** Condition 3.3.1(c) states The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in tables S3.1 and S3.4; (b) inlet quality specified in tables S3.1 and S3.4. (c) efficacy monitoring specified in tables S3.4 and S3.5. DCWW are required to comply with condition 3.1.1(c). - **Due 1 July 2026**
