On 12th May 2026 Angharad Clark and Mike Edwards attended site on an unannounced routine inspection and met with the operator/TCM.

The site was organised with all waste stored outside contained in skips and all waste stored inside in segregated piles. Some drums were noted but found to be empty.

Permitted activities

The volume of waste at site was well within the permit limits. No activities were being undertaken during the visit.

General Management

The permit and work plan were both readily available in the site office. No issues were found at site.
