The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 13/05/2026.

### **Issue**

No samples were taken out of ours, before 9am or after 3pm for 2025

**Action**

DCWW must improve their sampling operations to obtain out of hours samples to avoid future non-compliances.
