4. Details of our assessment

The non-compliance/s listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 13/05/2026.

Issue

Urban Waste Water Crude data for 01/03/2025 and 18/03/2025 was not provided within one month and was received on 25/11/2025.
