## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 12/05/2026.

### Issue identified

There was a sampling shortfall where 1 result for BOD, pH and Total Suspended Solids was missing for the calendar year. DCWW provided NRW with evidence of no flow from a sample taken on 21/05/2025 however this was rejected due to the quality of the photograph

being too dark to be accepted as evidence of no flow.

Improve operations to avoid future sampling shortfall
