4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as the non-compliance relate to the 2025 monitoring programme, however for clarity I carried out the compliance assessment on 12/5/2026

Issue

There was a late reschedule notification for the sample taken on 04/07/2025. The late notification was cited due to a courier temperature failure and procedures to cancel the analysis for affected samples were not followed. DCWW identified this issue in early September 2025 and the issue was raised with NRW on the 23rd October. Details were shared with NRW on the 28th October which is not within the 21 day window. These samples are not additional samples and they should have been rescheduled as soon as DCWW became aware.

Action

Improve the reporting process to avoid future issues with rescheduling samples.
