4. Details of our assessment

WQ-D3 - Notifications - Permit Condition 4.3.3 - C4

The non-compliance listed above was identified during our annual 2025 data audit.

This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

NRW received notification on 19/11/2025 of an increased frequency sample (for Iron) that had been taken on 18/11/2025. The OSM Sample Date was not provided in advance as per permit condition 4.3.3 and the clarification note.

Please ensure you comply with the 14 day notification note, as the date of an increased frequency sample was provided after the sample was taken.

Please note: this CAR is dated 19/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14/05/2026.
