4. Details of our assessment

LLANDDULAS LANDFILL

SITE RESPONSE TO WIR NO - 2602249

The above incident was reported to NRW on the 20 April 2026. Reporting pooling water on the ground around the grid located between Ty Gwyn and Bryn y Mor, in LLanddulas, at a downgradient groundwater monitoring borehole for the LLanddulas Landfill. Upon investigation by site staff, the cap on the monitoring well was found to be fractured and clean water was rising up from the ground through the fracture. See Photo below:



Site staff attended, reported findings to NRW and replaced the cap with a new one, responding as follows:

GWBH23 sits on a natural spring, the cap on the borehole had become split and groundwater was forced upwards leading to localised ponding of water in the area surrounding the grid. Enitial went out to site on 01/05/26 to investigate the issue, but were unable to resolve. Following this JSR went out on 02/05/26 and were able to pump the water down & replace the cap with a new one to resolve the issue, which has stopped water ponding

This issue will be monitored going forward but there are no further actions required by the operator at this stage and no CAR score as this was not deemed a breach of permit on this occasion.
