4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as the non-compliance relates to the 2025 monitoring programme, however for clarity I carried out the compliance assessment on 15/05/2026.

Issue identified:

The sampling frequency required for this site is 4 times a year, i.e. quarterly.

Original schedule dates were 11/02/2025, 17/06/2025, 08/08/2025, 30/10/2025. However, the February sample was rescheduled 7 times and was eventually collected on 12/08/2025. The June sample was also rescheduled twice due to the same issue and eventually collected on 11/09/2025. Due to the rescheduling the samples were unevenly distributed with 2 samples taken in August, 1 in September and 1 in October (site x4 frequency).

Please review the distribution of samples across the year to provide a more evenly spread programme.
