The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as the non-compliance relates to the 2025 monitoring programme, however for clarity I carried out the compliance assessment on 14/5/2026.

Efficacy Monitoring Shortfall. There was one sampling shortfall due to deviating data.
