4. Details of our assessment**This CAR form is being re-issued following additional information received from DCWW**

The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 12/05/2026.

Issue relating to discharge from discharge X Outlet 1

Condition assessed: 4.2.2 Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows: (a) in respect of the parameters and monitoring points specified in schedule 4 table S4.1; (b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and (c) giving the information from such results and assessments as may be required by the forms specified in those tables.

The information received on the original Annual Summary Report was misleading. Having received additional information from DCWW we accept the information received and assess this permit condition as compliant.

Issue Relating to discharge (Y)

Condition breached: 3.3.1 Sampling shortfall: 2 results for Total Suspended Solids, Chlorine, Iron and Aluminium missing for the calendar year.

There were 2 results for Total Suspended Solids, Chlorine, Iron and Aluminium missing for the calendar year. These were recorded on the Annual Summary report as being due to fluvial flooding, no access or natural obstruction. There seems to be a repeated issue on site with not obtaining samples due to fluvial flooding.

Action

Provide feedback to NRW on how DCWW plan on avoiding future issues of obtaining samples due to fluvial flooding issues.
