## 4. Details of our assessment

The non-compliance/s listed above was/were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Urban Waste Water.

Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 13/05/2026.

### Issue

It is a permit requirement to send monthly data 1 month in arrears e.g March data should have been sent by April but in this case was not sent until the following November.

DCWW are required to comply with U2(c) The consent holder shall provide to the Agency any information collected in complying with paragraph (b) above in a manner agreed with the Agency.
