This does not include List 1 substances included within a consent in the General Standards Table - 4 sampling shortfalls due to deviating data.

*The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, and Urban Waste Water conditions.*

*Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 12/05/2026.*
