## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14/05/2026.

The data audit found that the UWW Crude data for 07/03/2025 was not provided within the required 1 month time period and was received on 25/11/2025.

**Action:** Investigate the cause of the issue and improve on the reporting process to avoid future non-compliances.
