4. Details of our assessment

NRW received a notification from DC/WW on 30/04/2026 stating the following:

An Operator Self Monitoring (OSM) sample was taken on the 22nd April 2026. This sample

exceeded the permit limit for Biological Oxygen Demand (BOD). The permit limit is 40 mg/l and the result was 42 mg/l.

This was the first BOD exceedance recorded within the past 12 months; therefore, considering the site's sampling frequency, it is classified as a lookup table exceedance.
