## 4. Details of our assessment

Dear Permit Holder

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Cyf.'s compliance at all their sewage treatment works and water treatment works with UV conditions.

Please note: this CAR is dated 12/07/2025 as this non-compliance relate to annual 2025 data, however, for clarity the compliance assessment was undertaken on 14/05/2026.

**Issue Identified:**

**NUMERIC BREACH. UV Dose was below the lower limit on 12/07/2025 from 13:15 to 16:45 hours. Waiver rejected 24/09/2025. Dose below lower limit for >2.4 consecutive hours.**

**Action:**

Review and improve operations to avoid UV dose being lower than the limit within the permit in the future. Report improvements to NRW.

**Timescale:**

Action due date 1st July 2026.
