4. Details of our assessment

The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions and UV conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14/05/2026.

The data audit found that UV lamp data from 03/10/2025 was missing, which was also recorded in the fault log. Additionally, the audit identified a shortfall of one sample due to data deviation.

Action: Investigate the cause of the missing data and deviating sample and improve on the reporting and monitoring process to avoid future non-compliances.
