## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Urban Waste Water conditions.

UWW Crude data for 14/03/2025 was not provided within 1 month. Received 25/11/2025.

DCWW stated the root cause to be Februarys crude data being submitted instead of the data for March. NRW identified and raised this on 25/11/2025. The reason for this was said to be that the an error occured on the macro that is used for the file submission. The data for March was then submitted by DCWW to NRW on 25/11/2025.

*Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 18/05/2026.*
