4. Details of our assessment

The non-compliances listed above were identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions .

Please note: this CAR is dated 31 December 2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 18 May 2026.

Non Compliance 1 - Issue identified:

There were 4 sampling shortfalls due to deviating data.

Non Compliance 2 - Issue identified:

Due to human error, all failed dose readings were missing from the original fault report submitted on 26/11/2025. A corrected fault report was received on 23/12/2025 (NRW informed DCWW of the missing data on 15/12/2025), however this was past the 30/11/2025 deadline for quarter 3 data.
