## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 14/05/2026.

The annual data audit found that there were 2 results for biological oxygen demand (BOD), ammonia and total suspended solids missing for the calendar year. The missing results were reported on the Annual Summary Report as due to fluvial flooding.

**Action:** Provide feedback to NRW outlining how DCWW intends to prevent future sampling issues arising from fluvial flooding and deviating sample results.
