## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed monitoring and reporting compliance at all of your sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions where applicable and Urban Waste Water Treatment Regulations (UWWTR) conditions where applicable.

*Condition 4.2.2 requires that within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:*

- (a) in respect of the parameters and monitoring points specified in schedule 4 table S4.1;*
- (b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and*
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.*

Our data audit showed that the UWWTR Inlet (Crude) Sample Point data collected on the 19/03/2025 and 25/03/2025 was not submitted within the required 28 days from the end of March. You have explained that February's crude data was submitted instead of March's data. When we notified you of the missing data you then submitted it on the 25/11/2025. You have informed us that an investigation into the root cause identified that the macro used for the monthly reporting resulted in an error when producing the final file for submission. You have told us that the error has not occurred since and that an extra error step has been included in the Macro to prevent this from happening again.

**Action: Please ensure that you report the data required by condition 4.2.2 on time and that your systems are not preventing you from doing this.**

Under Regulation 38 (2) of the Environmental Permitting Regulations 2016, it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

You have already taken action to minimise the risk of a similar non-compliance from occurring again. Any Advice and Guidance in this report is given formally as part of our enforcement response.
