Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This

audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

The OSM sampling schedule for Cefn Gorwydd does not include samples that were subsequently taken on 13/08/2025, 24/09/2025, 06/10/2025, 07/11/2025 and 12/12/2025. This is a repeated failure to update the schedule or notify NRW of the updated schedule therefore has been scored as a Cat3 breach given the multiple opportunities to do so. Please review and improve the reporting procedure for any changes to the OSM sampling schedule to avoid future repeated non-compliances.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 18/5/26.
