## 4. Details of our assessment

*The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.*

*In line with Condition 4.2.2 the Annual Summary Report (ASR) was submitted to NRW as agreed, however an additional sample on Increased Frequency was taken for this site on 7 Feb 25 - after the declared end date of 31/1/25. Any inaccuracy like this in the ASR brings into question the validity of the whole report. In this instance the discrepancy seems to be a miscommunication or mis-understanding with dates and therefore has been categorised as a Cat 4 breach. You may wish to review internal processes to avoid any future repeat non-compliances.*

*Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 18/5/26.*
