Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions.

This site had a planned frequency of 4 samples across the year and the sampled dates are poorly distributed, with a large gap (almost 6 months) between the first and second samples despite being planned as quarterly. The timing of this gap could also mean the 'spring slough' would not be monitored potentially missing important data. This breach has been categorised as Cat4 given sufficient samples were taken but with an uneven distribution. "Roughly Equal Intervals" and "1 per Quarter" should both be considered when planning the OSM sample spread.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 18/5/26.
