4. Details of our assessment

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed monitoring and reporting compliance at all of your sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions where applicable and Urban Waste Water Treatment Regulations (UWWTR) conditions where applicable.

Condition 3.3.1 requires that you shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit:

(c) efficacy monitoring specified in tables S3.4 and S3.5.

Our data audit showed that UV Post-treatment efficacy samples taken on the 27/01/2025, 05/03/2025, 12/05/2025, 06/06/2025, 16/07/2025 and 04/08/2025 were flagged as deviating. Failure to reschedule and replace deviated samples results in a shortfall in the required number of samples taken.

Action: Please take action to ensure there is no shortfall in the number of reportable efficacy samples taken each year. Inform us of your findings and the actions you have taken.

Under Regulation 38 (2) of the Environmental Permitting Regulations 2016, it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

Any Advice and Guidance in this report is given formally as part of our enforcement response.
