4. Details of our assessment

The non-compliance listed above was identified during our annual data audit for 2025 data returns. This audit assessed Dŵr Cymru Cyf. compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (where applicable) and Urban Waste Water conditions.

Permit non-compliance identified:

The audit identified that some failed UV dose readings were missing from an original fault report for quarter 3 which was submitted on 26/11/2025. We received a corrected fault report on 23/12/2025 after NRW had informed Dwr Cymru of the missing data. However, this submission was then past the 30/11/2025 deadline for quarter 3 data, therefore is considered to be late.

This contravenes condition 15 (c) III of permit BW5103201 regarding Exception Reports - which states "*The Consent Holder shall supply to the Agency at three monthly intervals, or upon request, a written report, detailing all occurrences where: a Discharge of sewage effluent was made which had not been subjected to the required UV dose as specified in conditions 1(d) and 2 of this consent.*"

Dwr Cymru has already informed NRW that data were omitted in the original submission due to human error.
