year. This site has a frequency of x12 and the samples are poorly distributed in the last quarter with 3 being taken in November.

Samples taken as per original schedule: 16/01/2025, 05/02/2025, 14/03/2025, 16/04/2025, 02/05/2025, 20/06/2025, 25/07/2025, 18/08/2025, 29/09/2025, 17/11/2025, 21/11/2025, 26/11/2025.

The NRW interpretation of the permit “approximately equal intervals”, would be that the distribution is planned to reflect a true representation of the whole calendar year.
