## 4. Details of our assessment

### Summary Report

Breach of permit condition 4.2.2 - Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural

Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- (a) in respect of the parameters and monitoring points specified in schedule 4 table S4.1;
- (b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.

Table S4.1 states that reports for UWWTR must be submitted monthly (within 28 days).

February's crude data was submitted instead of March's data. This was raised by NRW on 25/11/2025. This was investigated and the root cause was the macro that is used for the monthly reporting, an error occurred when producing the final file for submission. March's data was submitted on 25/11/2025.

This error has not occurred since. An extra error step has been included in the Macro to prevent this from happening again.
