4. Details of our assessment

This Compliance Assessment Report (CAR) form has been produced following a review of the Q1 monitoring report submitted to Natural Resources Wales in April, and a site familiarisation visit carried out on 12th May 2026.

NRW officers met with the EHS Manager, Plant Manager, and Process Engineer at the start of the visit, and completed an inspection of the site accompanied by the EHS Manager and Process Engineer.

IR2B - The Site

The site was observed to be tidy and well organised.

The inspection covered the interior of the factory, including both production lines and the new resin plant associated with emission point A4. All emission and monitoring points were inspected internally and externally.

No issues were identified during the site inspection.

Quarterly Reporting of Emissions - Q1 (January to March 2026)**IR4B - Reporting**

VOC quarterly monitoring returns were submitted to NRW on 14th April 2026 which is within the required reporting period, and demonstrates compliance with IR4B - reporting, above, and permit condition 4.2.3

IR3A(2) - Emissions to Air

All readings for emission points A1, A2, A3, A5, A37 and A38 are within the required emission limits, thereby demonstrating compliance with permit condition 3.1.2 Schedule 3, Table S3.1

IR3E - Monitoring

Monitoring was carried out using accredited test methods, demonstrating compliance with IR3E - Monitoring, above, and with permit condition 3.5

Emission point A4

During the emissions testing period the new production line was undergoing plant start up and trials. Emission testing was attempted for A4, however the plant did not achieve stable operation due to mechanical failure and so the results obtained were not representative of normal operating performance. It is anticipated that the new production line will be up and running within the period mid-June to end July, so the first set of representative monitoring results are likely to become available for Emission point A4 during the third quarter of 2026.
