## 4. Details of our assessment

Natural Resources Wales (NRW) has reviewed the Construction Quality Assurance (CQA) validation report for Cell 5C (30759-Cell 5c Construction Quality Assurance Validation Report) which was submitted 02/04/26.

Cell 5 was sub-divided by the operator into 3 smaller cells, and Cells 5A and 5B have been built and are now operational. As the final cell in the series, the CQA procedures are well understood by the operator and the CQA Validation Report reflects this. The Validation Report has been compared with the requirements of the approved CQA Plan submitted to NRW in July 2025.

The groundwater collection system has been installed as described in the approved document, and the optional addition of counterfort drains to address localised seepages was not needed. The groundwater collection system includes the sumps and risers for the groundwater underdrain beneath the western half of Cell 5.

The mineral liner performance has been measured in a series of laboratory tests. The Validation Report reveals that the required frequency of testing has been exceeded so that the dataset is larger than that required by the CQA Plan. An analysis of the dataset has shown that with the exception of a rare outlier in classification data, the liner exceeds the requirement of the Plan. Importantly, the performance of the liner is without exception significantly better than the requirement of the CQA plan. Accordingly, the liner, the critical element of the construction works, is demonstrated to be acceptable.

The mineral liner is covered along its base with a drainage system comprising a gravel blanket overlying a geotextile separator. Testing has shown the material to meet the required grading and the topographic survey and placement thickness measurements have shown the drainage blanket to be of sufficient thickness. Appropriate pipework has been laid in the drainage blanket and three foundation slabs/target pads have been built.

The CQA Validation Report concludes with a series of verification statements confirming that each element of the works has been constructed in accordance with the CQA Plan. Having reviewed the CQA validation report and subsequent submissions, NRW are satisfied that Cell 5C can be brought into use.
