UWW Crude data for 30/03/2025 was not provided within 1 month. Received 25/11/2025.

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions. Please note: this CAR is dated 25/11/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 19/5/26
