#### 4. Details of our assessment

Compliance report of Marcross sewage works WQD009606 following a report to NRW of odour and flies emanating from the treatment works. Environment Officer Harry Warburton attended the site 20/05/26 at 11am.

There has been some progress at the works for maintenance on the reed bed. There has been vegetation cut back and the reeds removed, as well as the built up sludge/mud in the reed bed removed. The effluent is currently going through the reed bed without passing through reeds, however this is likely temporary whilst the maintenance work is ongoing. Due to the effluent not passing through the reeds it is exposed and creating a mild odour to the area, this could also be the cause of the flies in the report. At the time of attendance there were minimal flies in the area.

It was also noted that there was an unusual sound from the unit next to the treatment system, this should be investigated to ensure the treatment system is all functioning as intended.

Actions:

- Provide a timeline for the reed bed maintenance.
- Investigate the sounds from the unit next to the treatment system and report back the findings.
