OSM 13 Annual Summary Report. The frequency increase in Jan 2025 was not reported on the Changes to Sample Frequency tab.

E-mail from Sarah Atkinson 21/05/2025 set out the expectation that although the frequency for this site was increased in error, the change to frequency needed to be reported on the ASR as a record of why it happened.

The non-compliance listed above was identified during our annual 2025 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.

Please note: this CAR is dated 31/12/2025 as these non-compliances relate to annual 2025 data, however for clarity I carried out the compliance assessment on 13/05/2026.
