This Compliance Assessment Report (CAR) follows a routine site inspection at Kellogg's on 08/05/26. The Environment, Health and Safety (EHS) Manager and 2 EHS Practitioners accompanied Natural Resources Wales (NRW) officers during the visit.

The purpose of the visit was an awareness and familiarisation visit for the handover of the site to a new regulatory officer.

The balancing ponds were inspected and site staff gave an overview of the sampling and quarterly monitoring process.

No issues were identified during the inspection.
