## 4. Details of our assessment

### **SITE INSPECTION - GENERAL MANAGEMENT, PEST CONTROL AND FEEDSTOCK CONTAINMENT**

**Friday, May 01<sup>st</sup> 2025**

A site inspection was undertaken on the above date at 10:30hrs. to ascertain the efficacy of recent pest (bird) control measures on site following a further complaint of high numbers of flocking birds affecting the runway at Mona and RAF operations therein.

It was found that all of the agreed protocols between NRW/RAF Valley/Mona and Anglesey Energy are now in place.

The EMS covers the management and cleaning protocols for feedstock on site and are now keeping the site very clean and removing any feed source for birds. Constant cleaning after feeding the digester and weighted net coverage of clamps is having a profound effect on reducing the bird activity on site.

These protocols must be followed as a minimum to maintain control and avoid any potential future incidents.

The agreed protocols, which should now form part of the management system are now being followed and the site is fully compliant with these aspects of the permit.

The site will be inspected regularly both announced and un-announced over the coming 12 months to ensure standards are maintained.
