4. Details of our assessment

On the 5/1/2026 NRW sent CAR_NRW0050379 relating to an exceedance of Ammoniacal Nitrogen which is set at 5mg/l as a permit limit but was exceeded when a sample on the 12/1/2026 was at a level of 8.41mg/l. The CAR on the 5/1/2026 was actioned to record

compliance with the Look Up Table (LUT) provisions in the permit.

NRW received an exceptional circumstances claim report on the 3/2/2026 for the exceedance. Following internal consultation and consideration of the impacts of efficiency of treatment processes on effluents under 10 degrees in temperature we agree to waive the exceedance on this occasion.
