Routine water quality sample returned a suspended solids value of 119mg/l, this is higher than the maximum level permitted of 100mg/l.

As explained on the phone by the operator this failure occurred during a period of heavy rain where surface runoff caused the settlement ponds to overflow despite the circulation pump being switched on to minimise discharge volumes.

Please ensure your systems are maintained as designed and are able to cope with heavy rainfall events to prevent future failures.
