Following the previous inspection in September 2025, as detailed in **CAR_NRW0049406**, the following actions remained unclear in their response:

A follow up meeting was arranged to demonstrate their completion, with Officer C RHODES meeting an Engineer on behalf of the Technical Supervisor on Wednesday 20th May 2026, in relation to permit **TB3438AQ**. Weather at the time was a prolonged dry spell.

Upon arriving at site, the access chamber was clearly visible and accessible via manhole key, photographed below, addressing Actions 2 and 3 from the previous report. Once opened, the chamber was easily accessible for sampling, also photographed below.



It was discussed that the permit is primarily intended for discharge during an emergency and is little used day-to-day, but a variation is not necessary at this time.

Actions / further comments

No further actions are given at this time. The site was found be **compliant** with permitted condition 3.3.1 during the inspection.
