#### 4. Details of our assessment

This site visit was carried out as part of Natural Resources Wales' (NRW) active monitoring to assess ongoing compliance following the implementation of new procedures and engineering controls at the site. The purpose of the visit was to review the effectiveness of these measures, including the installation of concrete "Lego" block bays, in supporting sustained compliance.

The visit took place at World Care (Wales) Ltd, Plot 2a, Tremarl Ind. Estate, Llandudno Junction, Conwy, LL31 9PN on 26 May 2026 and was attended by NRW Waste Regulation Officer Cheryl Griffiths and Tackling Waste Crime officer Chris Nunn. Upon arrival, Officers were met by the Site Director, Lee Jones, and Sam Davies.

During the inspection, waste stockpiles were observed to be appropriately managed, remaining within the permitted height limit of 4 metres and contained within designated bays and skips, in line with the site's Fire Prevention and Mitigation Plan (FPMP) and environmental permit.

As discussed with Lee during the visit, NRW will now conclude this investigation and proceed to finalise our enforcement decision. Several visits have now been undertaken, which have demonstrated that the site has addressed the previously identified areas of non-compliance and is operating in accordance with the requirements of the environmental permit. On this basis, NRW is satisfied that the matter can be closed.

Routine monitoring will resume to ensure that standards are maintained and that the site continues to operate in compliance with the environmental permit.







Overall, positive improvements were noted across the site, reflecting the operator's cooperation and commitment to working with NRW to achieve and sustain compliance.
