4. Details of our assessment

This was an unannounced, site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the tier 3 bespoke Environmental Permit EPR-VP3498FV.

The weather was hot with strong sunshine.

Previous inspection:

No permit breaches were observed during the last inspection dated 28/05/2024 Please see Compliance Assessment Report CAR_NRW0044461 for further detail.

Permit Breaches:

No permit breaches were observed during this inspection.

General observations:

The site was generally clean and well organised with good segregation of waste types and good waste storage practices were observed.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution. Crushing activities are done once or twice a year when required, and there were clear and tidy storage piles of crushed aggregate.

The Site (W2D):

All specified waste sections were kept separate and site was well maintained. The interceptors are routinely emptied, and the drains are cleared using plant machinery due to the heavy nature of the drains. The drains showed signs of needed to be cleaned during the inspection, please ensure this is done when possible.

Reporting (W4B):

Up to date EMS and Site Permit were readily accessible on site. Latest Waste Return Notes up to date, up to Q1 2026.

Technical competence:

The TCM for the site holds the appropriate WAMITAB certification. The latest certificate was displayed on site, expiry date on Continual Competency is 10/04/2027.
